

Sweepstakes Terms and Conditions

1. Sponsor

This Sweepstakes (“Sweepstakes”) is sponsored by The Mattress Connect, located at 2850 34th St N #1124, St. Petersburg, FL 33713 (“Sponsor”). For more information, visit TheMattressConnect.com or contact us at info@TheMattressConnect.com

2. Eligibility

The Sweepstakes is open to legal residents of the 50 United States and the District of Columbia who are at least 18 years old at the time of entry. Employees, officers, directors, agents, and representatives of the Sponsor, its affiliates, and their immediate family members are not eligible to participate. International entries are not allowed; this Sweepstakes is strictly for U.S. residents.

3. Entry Period

The Sweepstakes begins for each mattress as soon as the first entry is made and ends when all 400 participant spots have been filled.

4. How to Enter

Participants may enter the Sweepstakes through the following options:

Purchase Options:

- **\$10 Tier: 1 entry**
- **\$20 Tier: 3 entries**
- **\$50 Tier: 10 entries**
- **Free Entry Option:** To enter without a purchase, participants may submit a handwritten entry on a 3”x5” card with their full name, mailing address, phone number, email address, and the specific mattress option they wish to enter (e.g., “King Purple Plus Soft Mattress”) to:

Only one free entry per person is allowed.

5. Limitations on Entries

- **Each sweepstakes for a specific mattress has a limit of 400 participants.** Once this limit is reached for a mattress, no further entries will be accepted for that mattress’s sweepstakes.
- Participants may enter multiple times across different tiers, but only **one free entry** per person per mattress is allowed.

6. Odds of Winning

- The odds of winning depend on the total number of entries received. If exactly 400 entries are received, each entry will have a 1 in 400 odds of winning. If there are more than 400 entries due to higher-tier purchases and free entries, the odds will decrease accordingly.

7. Prize

- The winner will receive the specific mattress they entered to win. This includes Free Delivery to the winner's designated address. Prizes are transferable; the winner may choose to give or sell the prize to another individual if they wish.

8. Winner Selection

- Each entry will be assigned a unique number to ensure transparency in the selection process. Once the limit of participants is reached, a live drawing will be conducted on Instagram (@TheMattressConnect) to randomly select the winners.

9. Claiming the Prize

- The winner has 7 days from the date of the drawing to claim their prize. If the winner does not claim their prize within this period, they forfeit the prize, and an alternate winner will be selected.

10. Publicity

- By entering, participants consent to the use of their name, likeness, and entry for promotional purposes without further compensation, except where prohibited by law.

11. Limitation of Liability

- By participating in the Sweepstakes, entrants agree to release and hold harmless the Sponsor, its affiliates, and their respective officers, directors, employees, and agents from any liability, claims, or damages arising from participation in the Sweepstakes or acceptance, use, or misuse of the prize.
